BE IT RESOLVED, by the Council of The City of San Diego, that the Financial Management Department be and it is hereby authorized and directed to include for consideration in the annual appropriation ordinance for the FY 1987 Capital Improvement Budget, the design of the Oceanview Boulevard widening in the FY 1992 CIP budget phase and commencement of
