BE IT FURTHER RESOLVED, that the City Manager be and he is hereby authorized and empowered to pay the sum of \$250,000.00 in the settlement of Superior Court Case No. 534910, Thomas Carter and Cal Street Builders v. City Council, The City of San Diego, et al., pursuant to and in accordance with all the terms and conditions contained in the Settlement Agreement dated March 10, 1986 regarding a lawsuit filed February 1, 1985 by plaintiffs' concerning development of a project known as "Golden Hill Villas".

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby authorized to execute, accept and enter into the Negative Easement Agreement, a copy of which is on file in the Office of the City Clerk as Document No. RR- 20532 , and incorporated into and made a part of the Settlement Agreement dated March 10, 1986 between Thomas Carter and Cal Street Builders and the City of San Diego thereby accepting .67 acres of open space or "BUFFER area" within the "Golden Hill Villas" development.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be and he is hereby authorized to issue one check to Thomas Carter and Cal Street Builders and their attorney of record, James Dawe, in the amount of \$250,000.00 in full settlement of the lawsuit and all claims.
