BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bid of AMERICAN PROCESSING CO., INC. is hereby accepted and the City Manager is hereby authorized to execute a contract for REMOVAL & DISPOSAL OF RAGS AND VARIOUS OTHER MATERIALS from sewage flow at Pump Station No. 1 and No. 2 as may be required for a period of one (1) year beginning June 1, 1986 through May 31, 1987, at a cost of \$164.50 per haul, for a total estimated cost of \$59,878.00; terms  $\frac{1}{2}$  of 1% 30 days, with an option to renew contract for an additional one (1) year period with a price escalation not to exceed 5% of prices bid.
