
RESOLUTION NUMBER R- 265551

ADOPTED ON APR 28 1986

BE IT RESOLVED, by the Council of The City of San Diego, that the acceptance by the City Manager of four (4) street easement deeds of LEO ANTHONY MCGUIRE, dated October 25, 1985; THE CORPORATION OF THE PRESIDING BISHOP OF THE CHURCH OF JESUS CHRIST OF LATTER DAY SAINTS, a Utah corporation sole, dated February 10, 1986; VILLAGE PROPERTIES, a partnership, dated December 27, 1985; and FRANK E. GRANT, STEVEN PARK GRANT, KATHRYN TYLER GRANT SCHULZ and PETER KENT GRANT, dated September 27, 1985; all executed in favor of The City of San Diego, copies of which deeds are on file in the Office of the City Clerk as Document Nos. RR-265551-1, RR- 265551-2, RR- 265551-3 and RR- 265551-4, granting to said City easements for public street purposes in portions of Parcels 1 and 3 of Parcel Map No. 13449; Parcel 3 of Parcel Map No. 11045 and in a portion of Section 18, Township 14 South, Range 3 West, San Bernardino Meridian, as more particularly described in said deeds, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for public streets, and the same are hereby named TORREY BLUFF DRIVE, MCGUIRE DRIVE and CARMEL COUNTRY ROAD.

BE IT FURTHER RESOLVED, that the City Clerk shall cause the deeds and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
