RESOLUTION NUMBER R- 265569

ADOPTED ON APR 28 1986

WHEREAS, the President has signed HR 3128, a budget reconciliation bill, which provides over \$675 million in new revenue to the State of California and requires all newly hired local government employees to participate in the Medicare Program effective April 1, 1986; and

WHEREAS, the medicare provision in the reconciliation bill requires that employees hired after March 31, 1986 will contribute 1.45% of their base salary to the Medicare System and the City will also be required to match with an equal 1.45% contribution; and

WHEREAS, the background and discussion of the matter is set forth in IRD Report No. 86-19, dated April 7, 1986; and

WHEREAS, the Rules Committee considered the matter at its regularly scheduled meeting of April 7, 1986 and voted 4-0 to forward the matter to the full Council for appropriate action;
NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager and other relevant non-managerial departments be and they are hereby directed to review HR 3128 and its

implementing regulations so that the City can carry out the provisions of this new law.
