RESOLUTION NUMBER R- 265582

WHEREAS, DALEY CORPORATE CENTER, a California general partnership, has requested an exchange of sewer easements; and

WHEREAS, the City Manager has certified that the values of the property rights to be exchanged are equal; and

WHEREAS, the easement to be acquired on the final map of Murphy Canyon Gateway Unit No. 1 will serve the same use and purpose as the easement to be quitclaimed by the City; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:


1. That the acceptance of that sewer easement, as shown on the final map of Murphy Canyon Gateway Unit No. 1, be and the same is hereby approved.

2. That the Mayor and City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, a copy of which is on file in the office of the City Clerk as Document No. RR- 265582-1, quitclaiming to DALEY CORPORATE CENTER, a California general partnership, all of the City's right, title and interest in the sewer easement in a portion of Lots 6 and 7, Block 28 of Rosedale, Map 826, as more particularly described in said deed.

3. That the City Clerk is hereby authorized and directed to deliver the quitclaim deed, and a certified copy of this

resolution, attested by him under seal, to the Engineering and Development Department for further handling.
