RESOLUTION NUMBER R- 265585

ADOPTED ON APR 28 1986

WHEREAS, The City of San Diego is the owner of a slope easement in a portion of Lots 6 and 7, Block 28 of Rosedale, Map 826; and

WHEREAS, the City desires to negotiate the sale of said land to DALEY CORPORATE CENTER, a California general partnership, under the provisions of Section 22.0902 of the San Diego Municipal Code, which permit the sale of real property belonging to The City of San Diego by negotiation; and

WHEREAS, the sale of such real property as this may reasonably be accomplished by negotiation; and

WHEREAS, the slope easement was acquired at no cost and the City has no fee interest; and

WHEREAS, the value of the property to be conveyed by the City is nominal, therefore it can be sold for the processing fee; and

WHEREAS, no real estate broker's commission shall be paid; and

WHEREAS, the sale of the aforementioned property right is consistent with the public interest; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That that certain real property described in that grant deed on file in the office of the City Clerk as Document No.

RR- 265585, be, and the same is hereby authorized to be


sold, for the processing fee, to DALEY CORPORATE CENTER, a California general partnership.

2. That the Mayor and City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a grant deed, a copy of which is on file in the office of the City Clerk as Document No. RR- 265585, granting to DALEY CORPORATE CENTER, a California general partnership, all that portion of the slope easement in Lots 6 and 7, Block 28 of Rosedale, Map 826, as more particularly described in said grant deed.

3. That no broker's commission shall be paid by The City of San Diego on the herein described negotiated sale.

4. That the City Clerk is hereby authorized and directed to deliver said deed and a certified copy of this resolution, attested by him under seal, to the Engineering Department for further handling.
