MANAGERIAL RECRUITMENT."


WHEREAS, the City Council has previously expressed a desire to adopt a policy dealing with appointing authority authorization to incur expenses in the recruitment of individuals not currently employed by the City to fill vacancies in the executive and managerial services; and

WHEREAS, the policy would allow appointing authorities to pay travel costs including transportation, meals and lodging of individuals invited to interview and moving costs of individuals relocating in order to accept a position with the City; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that Council Policy No. 000-28 entitled "EXPENSES FOR EXECUTIVE AND MANAGERIAL RECRUITMENT" be and is hereby established as set forth in the Council Policy filed in the Office of the City Clerk as Document No. RR- 265586 .

BE IT FURTHER RESOLVED, that the City Clerk is hereby directed to add the aforesaid to the Council Policy Manual, and publish and distribute the new policy as may be necessary and required.
