BE IT RESOLVED, by the Council of The City of San Diego as follows:

MIDLAND LMR BY COUNTY WIDE COMMUNICATIONS are hereby accepted and the City Manager is hereby authorized to execute contracts for the purchase of COMMUNICATIONS EQUIPMENT as may be required for the period of eight (8) months beginning April 1, 1986 through December 31, 1986, per prices on file in the Purchasing Department, with an option to renew contracts for an additional one (1) year period, price increases not to exceed 13% of original contract pricing.

(2) GENERAL ELECTRIC COMPANY - M.C.D. for Items 3B, 12B, 13B, 14A, 17A, 21B, 22B, 33B, 35; terms net 30 days, plus sales tax.


(3) CALIFORNIA MOBILE COMMUNICATIONS for Items 13A, 28A, 35; terms net 30 days, plus sales tax.
