ADOPTED ON APR 28 1986

BE IT RESOLVED, by the Council of The City of San Diego, that this Council expresses no objection to the proposed Otay Valley/Palm Avenue Reorganization, if agreements which provide for the following requirements are executed by the City of San Diego prior to the hearing being held by the conducting authority:


1. The City of Chula Vista shall agree to annually reimburse the City of San Diego in full for any and all taxes which accrue on segments of the Coronado and South San Diego water pipelines and the Otay Valley Trunk Sewer that lie within the territories to be detached.

2. If designated within an Area of Benefit, the owners of properties within the territories to be detached shall agree to participate fully in any Facilities Benefit Assessment created by the City of San Diego.

3. The City of San Diego Water Utilities Department shall retain unrestricted rights of access for purposes of maintenance, repair, or replacement of those segments of the Coronado and South San Diego water pipelines and the Otay Valley Trunk Sewer that lie within the territories to be detached.
