VACATION OF VIRGINIA AVENUE SOUTH OF BORDER  
VILLAGE ROAD AND ADJACENT TO LOT A-164 SAN  
YSIDRO ADDITION MAP 1194 AND A PORTION OF  
SECTION 1 T19S R2W.

WHEREAS, it is proposed that Virginia Avenue south of Border Village Road be vacated; and

WHEREAS, there is no present or prospective use for the street either for the public street system for which the right-of-way was originally acquired or for any other public use of a like nature that can be anticipated in that the right-of-way is no longer needed for public street or open space purposes; and

WHEREAS, the public will benefit from the vacation through improved utilization of land; and

WHEREAS, the vacation is not inconsistent with the General Plan or an approved Community Plan; and

WHEREAS, the public street system for which the right-of-way was originally acquired will not be detrimentally affected by this vacation; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That Virginia Avenue south of Border Village Road, as more particularly referred to in Resolution of Intention No. R- 265309, adopted by the Council on MAR 31 1986, 1986, is not necessary for present or prospective public street purposes.

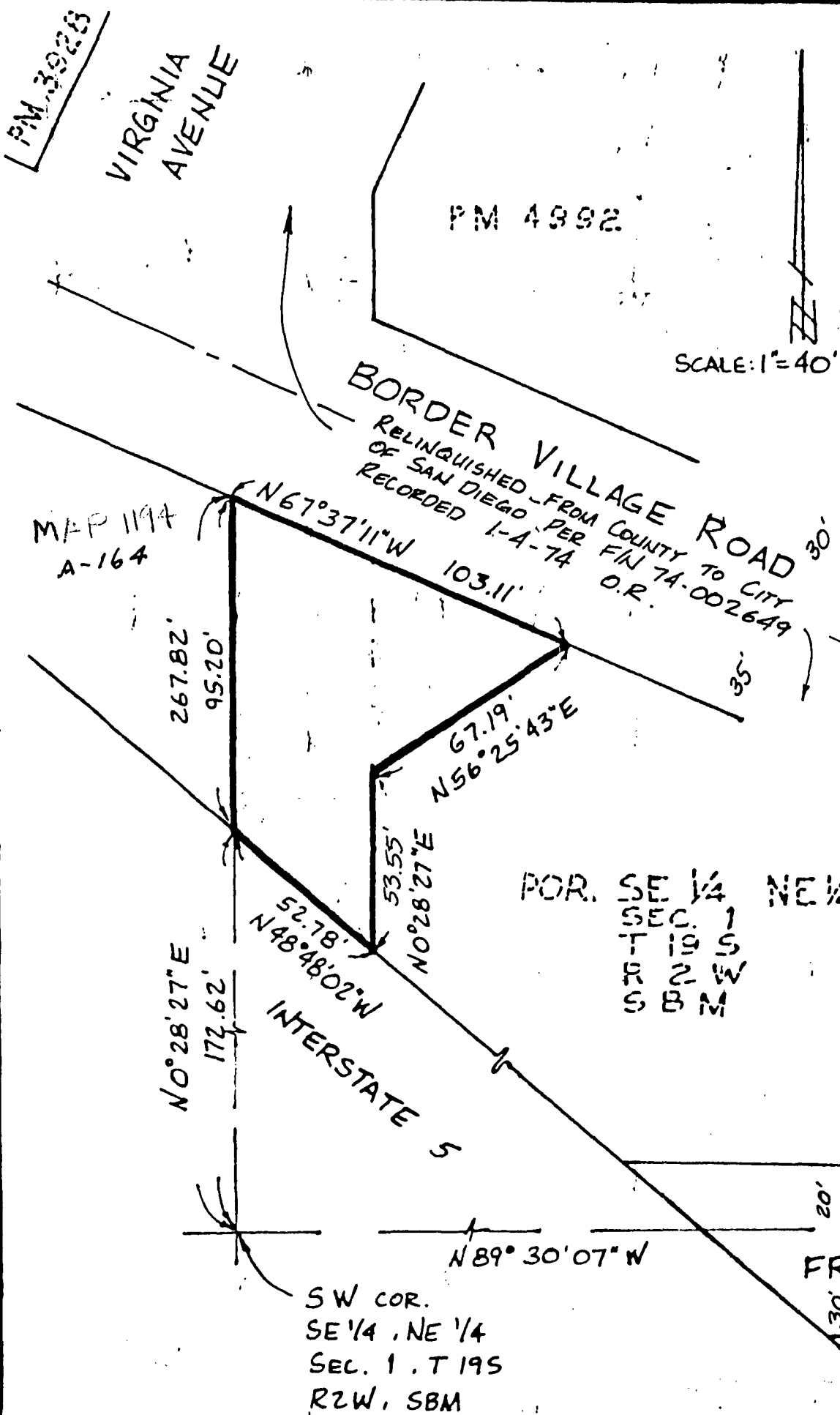

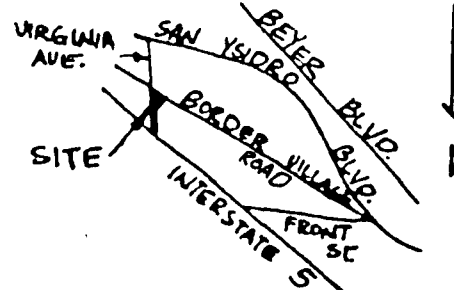
