BE IT RESOLVED, by the Council of The City of San Diego, that the City Auditor and Comptroller be and he is hereby authorized to transfer the sum of five thousand dollars (\$5,000) within Fund 100 from the Unallocated Reserve (605) to the Allocated Reserve (901) for the sole and exclusive purpose of providing funds to augment Resolution No. R-264392 for expenses incurred in connection with said participation in the above California Public Utilities Commission and Federal Power Commission hearings relating to the San Diego Gas & Electric Company.
