RESOLUTION NUMBER R- 265658

ADOPTED ON MAY 12 1986

WHEREAS, the proliferation of pornography should not be tolerated in an orderly society; and

WHEREAS, the dissemination of pornographic materials has reached such epidemic proportions that President Reagan recently formed a Commission on Pornography to study its impact on society as a whole; and

WHEREAS, studies have indicated that there is a nexus between the viewing of pornographic material and acts of violent aggression against individuals; and

WHEREAS, today's young people are tomorrow's future; and

WHEREAS, it is our obligation to assist in the perpetuation of conduct in our society which enhances our quality of life; and

WHEREAS, it is the responsibility of each member of our community to protect our citizens from the harmful impacts of pornography; and

WHEREAS, the Southland Corporation in their continuing expressions of commitment and spirit of family have voluntarily removed all pornographic magazines and books from their three thousand corporately-owned stores; and

WHEREAS, their estimated profit loss is projected to be \$30 million per year by this action; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that Southland Corporation be congratulated for placing principle,

family, and community concern above their financial gain, and that this City can sincerely say, "Thank Heaven for 7-11."
