


RESOLUTION No. R-265661 (R-86-1891)

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bid of CHULA VISTA TRANSFER, INC. is hereby accepted and the City Manager is hereby authorized to execute a contract for furnishing OFFICE RELOCATION SERVICES as may be required for a period of one (1) year beginning August 1, 1986 through July 31, 1987, per prices on file in the Purchasing Department, for a total annual estimated cost of \$36,000.00; terms net 30 days, plus applicable sales tax on materials, with an option to renew contract for an additional one (1) year period with an escalation not to exceed 10% of prices in effect at the end of prior year.
