Herman Lancaster	Utilities	\$320.00	Mr. Lancaster is a Water Plant Operator in the Water Production Division. He suggested the installation of a reset button on the chlorine alarm system. Although savings were difficult to identify, this was considered to be a significant safety improvement.
Phil McNeely	Park & Recreation	\$ 99.76	Mr. McNeely is an outside welder with General Services Equipment Division. One year ago, he earned a partial award of \$760 for his suggestion to spot weld nuts to bolts on bleachers to prevent theft. One year's experience has shown a savings of \$2,865.85. This is the remainder of his award.
Veronica Seyde	Utilities	\$ 90.00	Ms. Seyde is an Assistant Laboratory Technician in the Wastewater Division. She suggested the use of Silica Gel (S-689) for laboratory desiccators. Although savings were difficult to identify, this was considered to be a significant operational improvement.
