

RESOLUTION NUMBER R- 265719

ADOPTED ON MAY 13 1986

WHEREAS, The City of San Diego is supporting the placement of "JUST SAY NO" clubs in the elementary schools in our City; and

WHEREAS, 35,000 of San Diego's citizens joined together on March 1, 1986 to collectively say "no to drugs"; and

WHEREAS, over 150 youngsters and professional athletes combined their voices to sing "Winners Just Say No", a theme song for the rally against drugs, written and recorded in San Diego; and

WHEREAS, the USS Okinawa, berthed in San Diego, was the stage where thousands of San Diego's children spelled out "SAN DIEGO SAYS 'NO' TO DRUGS"; and

WHEREAS, The City of San Diego hopes to achieve 100% participation in saying "no to drugs"; and

WHEREAS, Countess Wachtmeister, the wife of the Swedish ambassador, has been engaged in an ongoing crusade against drugs, on behalf of children; and

WHEREAS, she now wishes to expand the movement by making it an international effort; and


WHEREAS, she has in the process volunteered her dog, Chloe, to be the official mascot of the fight against drugs; NOW, THEREFORE,
