
ADOPTED ON MAY 19 1986

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with Economics Research Associates, Inc., for a redevelopment feasibility study of the Mid-City and North Park areas, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 265737 .

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$70,000 (\$8,822 from Fund 18517, Department 5992, Organization 9204; \$6,609 from Fund 18518, Department 5617, Organization 1707; and \$54,569 from Fund 18519, Department 5717, Organization 1712), is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
