

RESOLUTION NUMBER R- 265746

ADOPTED ON MAY 19 1986

WHEREAS, the Bylaws of the San Diego Trolley, Inc. (section 3.2) provides that The City of San Diego shall have four (4) directors on the Board of Directors of said corporation; and

WHEREAS, said section 3.2 also requires that the initial terms of office of the four directors shall be staggered so that one (1) shall be for one year, two (2) shall be for two years, and the last one (1) for three years; and

WHEREAS, thereafter, the terms shall be for a standardized three-year term; and

WHEREAS, the terms of the present City representatives were not itemized when they were selected earlier this year and it is now appropriate to do so; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the terms of the City's representatives to the San Diego Trolley Board of Directors are hereby declared to be as follows:
