
RESOLUTION NUMBER R- 265779

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and directed to execute, for and on behalf of THE CITY OF SAN DIEGO, an amendment to the subdivision agreement for THE WOODS AT SCRIPPS RANCH UNIT NO. 4, on file in the office of the City Clerk as Document No. RR- 265779, to provide for the substitution of MERCURY SAVINGS AND LOAN ASSOCIATION, a United States corporation, for SCRIPPS RANCH ASSOCIATES, a joint venture, as subdivider.

BE IT FURTHER RESOLVED, that Performance Bond No. 137645, issued by INSURANCE COMPANY OF THE WEST, in the amount of \$1,001,250.00 is hereby accepted as the surety for the required improvements in said subdivision, and substituted as Exhibit "C" to the aforesaid agreement and that Instrument of Credit, issued by MERCURY SAVINGS AND LOAN ASSOCIATION, in the amount of \$1,001,250.00, is hereby released.
