RESOLUTION NUMBER R- 265783

ADOPTED ON MAY 27 1986

WHEREAS, section 8330 et seq. of the California Streets and Highways Code provides a procedure for the summary vacation of streets by City Council resolution where the portion of street to be vacated is excess right-of-way which is unimproved and has been impassable to vehicular traffic for the preceding five years and no public moneys have been expended for maintenance upon the portion of the street to be vacated for the preceding five years; and

WHEREAS, the abutting property owner has requested the vacation of the southerly $\frac{1}{2}$ of the east/west alley between Reynard Way and Eagle Street and adjacent to Lot 66 of Reynard Hills, Map 2097; and

WHEREAS, the public will benefit from the vacation through improved utilization of land; and

WHEREAS, the vacation is not inconsistent with the General Plan or an approved Community Plan; and

WHEREAS, the portion of the street to be vacated is not needed for present or prospective public street purposes; and

WHEREAS, the southerly $\frac{1}{2}$ of the east west alley between Reynard Way and Eagle Street has been impassable to vehicular traffic and no public moneys have been spent thereon for the preceding five years; and


WHEREAS, those properties adjoining the street to be vacated will continue to have access; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the southerly $\frac{1}{2}$ of the east/west alley between Reynard Way and Eagle Street and adjacent to Lot 66 of Reynard Hills, Map 2097, as more particularly shown on Drawing No. 16686-B on file in the office of the City Clerk as Document No. RR- 265783 -1, which is by this reference incorporated herein and made a part hereof, be and the same is hereby ordered vacated.

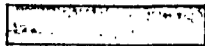
2. That the City Clerk shall then cause a certified copy of this resolution, attested by him under seal, with drawing, to be recorded in the office of the County Recorder.

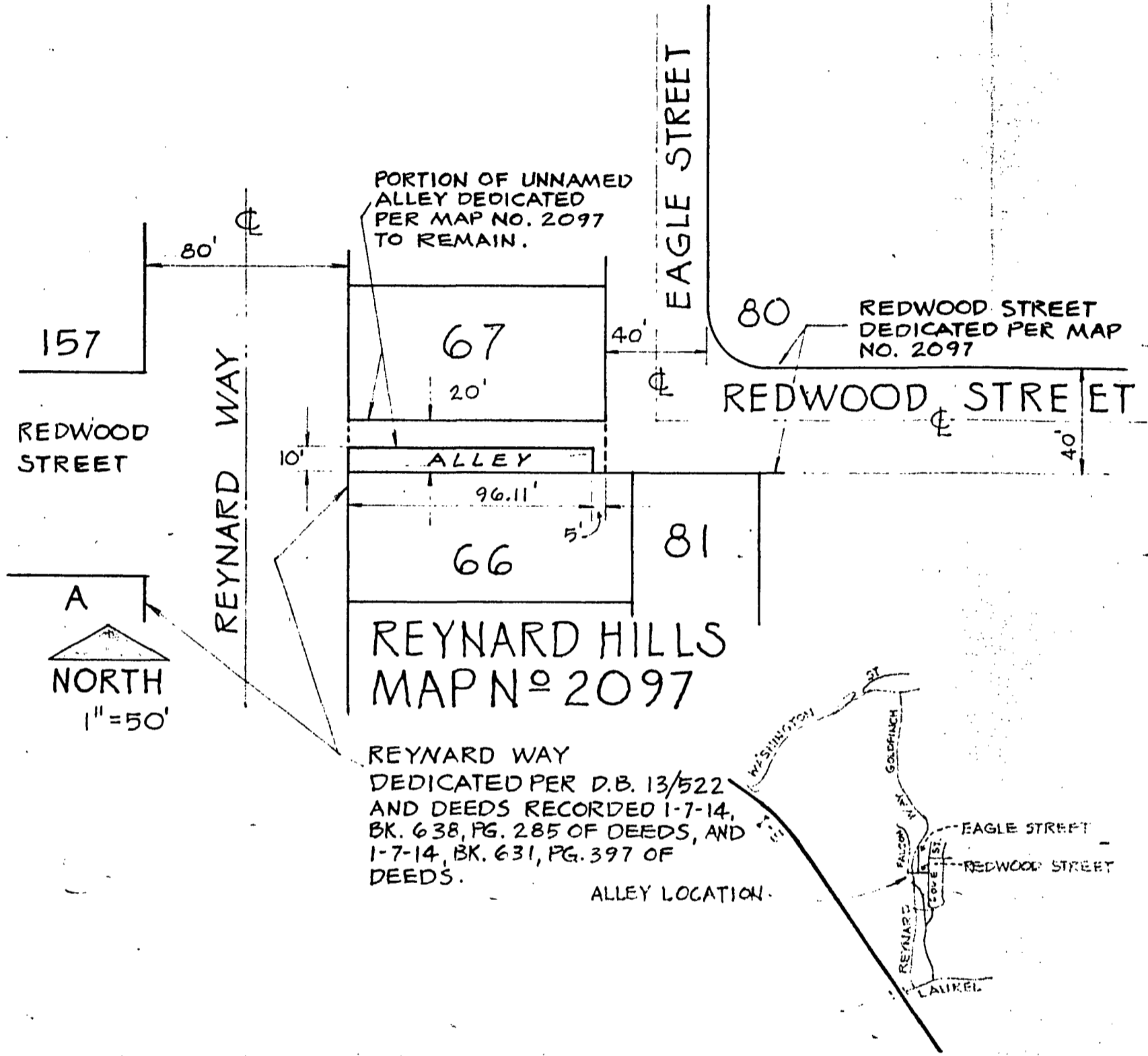
