RESOLUTION OF THE CITY OF SAN DIEGO REQUESTING
A GRANT FROM THE DEPARTMENT OF BOATING AND
WATERWAYS FOR THE IMPROVEMENT OF A BOAT
LAUNCHING FACILITY AT DE ANZA COVE, DANA
LANDING AND SKI BEACH.

WHEREAS, The City of San Diego ("City") is desirous of improving a boat launching facility at De Anza Cove, Dana Landing and Ski Beach to meet the needs of the boaters and to provide public access to the water; and

WHEREAS, the Department of Boating and Waterways is authorized to provide grants to cities, counties, districts, and other public agencies for the construction and development of small craft launching facilities; and

WHEREAS, the City has conducted an inventory of existing boat launching facilities in the area and has determined that the proposed project will not be detrimental to the operations of private boating businesses in the area; and

WHEREAS, the City has provided a forum for comments and has determined that the proposed project is needed to provide the public with access to the waterfront; and

WHEREAS, the City has conducted a feasibility study which showed the proposed project to be feasible from an engineering and financial stand point and economically justified; and

WHEREAS, the City is willing to enter into an agreement to provide for the operation and maintenance of the proposed facilities at no cost to the State; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, that this Council hereby requests that the Department of Boating and Waterways provide a grant for the purpose of improving a public use boat launching facility at De Anza Cove, Dana Landing and Ski Beach.

BE IT FURTHER RESOLVED, that the City agrees to accept the grant and hereby authorizes the City Manager or his representative to sign the grant agreement and execute any necessary documents and accept the grant for the purpose stated above.

BE IT FURTHER RESOLVED, the the City Auditor and Comptroller is hereby authorized to establish an interest bearing special fund for receipt of these monies.
