RESOLUTION NUMBER R- 265801

ADOPTED ON MAY 27 1986

WHEREAS, the Century Club of San Diego is a nonprofit organization which supports the Andy Williams Golf Tournament as part of the Professional Golf Association Tour event in San Diego; and

WHEREAS, concession sales of food, drink, and merchandise on the Torrey Pines Golf Courses is the exclusive right of the Torrey Pines Inn in accordance with the terms of their lease agreement with the City; and

WHEREAS, in previous Andy Williams Golf Tournaments, the Torrey Pines Inn has waived the right to operate the on-course concessions and transferred that right to the Century Club of San Diego, sponsors of the tournament; and

WHEREAS, in a recent City audit it was noted that percentage returns on the concession sales for 1984 and 1985 tournaments totaling \$8,936 is due the City from the Century Club; and

WHEREAS, the Century Club of San Diego is now requesting that these concession fees be waived, since proceeds from the 1984 and 1985 tournaments have already been distributed to local charities and to the Junior Golf Program; and


WHEREAS, the Council finds that such a waiver of fees is appropriate in view of the many benefits to the City of San Diego that the Century Club's sponsorship of this event has brought;

NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the waiver of \$8,936 in concession fees due from the Century Club of San Diego for the 1984 and 1985 Andy Williams San Diego Open golf tournaments is hereby authorized.
