RESOLUTION NUMBER R- 265802

ADOPTED ON MAY 27 1986

WHEREAS, the City Auditor's audit of the SAN PASQUAL VINEYARDS for calendar year 1984 revealed an audit deficiency of \$10,889 in unpaid rent due the City; and

WHEREAS, the lessee has protested the Auditor's findings on the basis that \$7,833 of the deficiency should not be required to be paid under the terms of the lease; and

WHEREAS, the matter was referred to the City's Agricultural Advisory Board, which Board recommended that the \$7,833 rent amount be waived by the City Council; and


WHEREAS, the City Manager has recommended that \$2,090 of the \$7,833 rent deficiency not be waived; and

WHEREAS, the Public Facilities and Recreation Committee has recommended that the entire \$7,833 be waived; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that \$7,833 of the total rental deficiency as shown in the above-specified audit for the SAN PASQUAL VINEYARDS relating to imported wine commissions and custom crushed grapes, be waived.
