WHEREAS, the conference included several workshops related to nationwide police issues, covering matters of great relevance to the criminal justice system; and

WHEREAS, the Police Department hosted three specific functions to include law enforcement officials and spouses, at City expense during the conference; and

WHEREAS, the City Manager and Financial Management Director had been briefed about and approved the hosting function by the Police Department as serving a valuable public purpose for the City; and

WHEREAS, the conference also promoted The City of San Diego as a leader in the tourist industry; and

WHEREAS, as a result thereof, the benefits accruing to the City as a vacation location was greatly enhanced; and


WHEREAS, it is now requested that the City Council authorize the Auditor and Comptroller to process the request for payment of
