WHEREAS, the June 1986 State Primary Election Ballot includes eleven statewide propositions; and

WHEREAS, said statewide propositions are numbered consecutively as Propositions 42 through 52; and

WHEREAS, the full City Council has taken a position of support on Propositions 45, 49 and 51 by prior Council action; and

WHEREAS, summaries and recommendations for each of the remaining propositions have been provided by the Intergovernmental Relations Department in its IRD Report No. 86-28, dated May 13, 1986; and

WHEREAS, the Rules Committee reviewed the various propositions at its meeting of May 19, 1986, and determined to make recommendations to the full Council on five of the remaining eight statewide propositions; and

WHEREAS, the Rules Committee now forwards the matter to the full City Council with a recommendation that the City Council support Propositions 43, 46, 47, 50 and 52 as summarized in IRD Report No. 86-28; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Rules Committee recommendations in respect to Propositions

43, 46, 47, 50 and 52 on the June 1986 State Primary Election
Ballot, be and the same are hereby approved and adopted.
