WHEREAS, Council Policy 600-7 provides that public hearings to consider revisions to the Progress Guide and General Plan for The City of San Diego may be scheduled concurrently with public hearings on proposed community plans in order to retain consistency between said plans and the Planning Commission and City Council have held such concurrent public hearings; and

WHEREAS, the City Council has considered all maps, exhibits and written documents contained in the file for this project on record and has considered the oral presentations given at the public hearing; NOW, THEREFORE,
