

BE IT RESOLVED, by the Council of The City of San Diego as follows:

Council resolution as follows:

1. That the low bid of MCKESSON CHEMICAL COMPANY is hereby accepted and the City Manager is hereby authorized to execute a contract for furnishing LIQUID CAUSTIC SODA as may be required for a period of one (1) year beginning July 1, 1986 through June 30, 1987 at a cost of \$154.99 per ton, total estimated cost of \$246,046.63; terms net 30 days, plus applicable sales tax.
2. That the Purchasing Agent is hereby authorized to purchase liquid caustic soda on an emergency basis, in the event the contract vendor fails to deliver caustic soda on any occasion, from Van Waters & Rogers, Holchem Inc., Occidental Chemical Corp., PPG Industries Inc., Baron Blakeslee Inc., or Crown Chemical Corp. per prices on file in the Purchasing Department.
