

RESOLUTION NUMBER R- 265850

ADOPTED ON JUN 2 1986

A RESOLUTION ELECTING TO PROCEED UNDER THE PROVISIONS OF THE PUBLIC STREETS, HIGHWAYS, AND SERVICE EASEMENTS VACATION LAW, DECLARING THE INTENTION OF THE CITY COUNCIL TO VACATE SANTA PAULA DRIVE, SAN DIMAS AVENUE, SANTA ANA DRIVE AND A PORTION OF MARIAN WAY ALL NORTHERLY OF LINDA VISTA ROAD, AND FIXING A TIME AND PLACE FOR HEARING THEREOF.

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the public interest and convenience of said City require the vacation of Santa Paula Drive, San Dimas Avenue, Santa Ana Drive and a portion of Marian Way, hereinafter mentioned.

2. That it is the intention of said Council to order the vacation of Santa Paula Drive, San Dimas Avenue, Santa Ana Drive and a portion of Marian Way, as more particularly shown on Drawing No. 22213-D on file in the office of the City Clerk as Document No. RR- 265850.

3. That this Council hereby elects to proceed, in making said vacation under the provisions of the "Public Streets, Highways, and Service Easements Vacation Law." California Streets and Highways Code section 8300 et seq.


4. That this Council hereby fixes 10:00 a.m. on July 1, 1986, in the Council Chambers on the twelfth floor of the City Administration Building, Charles C. Dail

Concourse, 202 "C" Street, in said City of San Diego, as the time and place for hearing all persons interested in or objecting to the proposed vacation.

5. That The Daily Transcript, a daily newspaper published and circulated, and of general circulation, in said City of San Diego, be, and it is hereby designated as the newspaper in which the Street Superintendent of said City shall cause to be published, in the manner and form required by law, notice of the passage of this Resolution of Intention, and the Street Superintendent is hereby directed to cause notices of the passage of this resolution to be posted in the manner and form required by law and to cause a notice similar in substance to be published in said newspaper in the manner required by law.
