

RESOLUTION NUMBER R- 265852

ADOPTED ON JUN 2 1986

WHEREAS, AB 3506 (Hayden) extends the reporting requirements for persons who discharge hazardous wastes; and

WHEREAS, the bill also makes an employer who fires, suspends, or otherwise discriminates against an employee who reports such a discharge civilly liable to the employee; and

WHEREAS, the Rules Committee on May 5, 1986, declined to accept the Personnel Department's recommendation that the bill be amended to exempt public employees from civil liability; and

WHEREAS, the Committee directed the Personnel Director to propose an amendment that would protect the interests of both the City and an employee making a report; and

WHEREAS, the Personnel Director proposed and the Rules Committee of May 19, 1986, approved the following amendment:

Provided, however, that employees reporting to a public or private official must simultaneously follow their own employer's rules and procedures regarding internal reporting to enable immediate response when possible. In the absence of local reporting procedures, employees must make every reasonable effort to immediately notify the responsible employer along with the appropriate agency.

and

WHEREAS, the Rules Committee now forwards the matter to the full Council for consideration; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego that this Council hereby expresses support for AB 3506 (Hayden) provided it is amended as recommended by the Personnel Director, said recommendation set forth in IRD Report No. 86-30, dated May 15, 1986.
