
BE IT RESOLVED, by the Council of The City of San Diego, that the City Auditor and Comptroller is hereby authorized to establish the Mira Mesa Traffic Mitigation Fund (Fund No. 10506), which shall be used for the purpose of financing improvements to the Mira Mesa/I-805 interchange, Camino Santa Fe and Scranton Road, as more particularly described in the City Engineering Department Letter dated September 24, 1984, attached hereto as Attachment "A."

BE IT FURTHER RESOLVED, that this fund shall be authorized to accrue and retain interest earned for the purposes of the fund.

BE IT FURTHER RESOLVED, that the funds previously submitted or to become due to the City in compliance with conditions imposed on Mira Mesa Business Park (TM 83-0858) be transferred to Fund No. 10506.

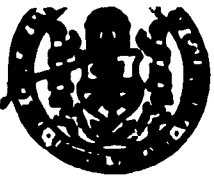

We are ready to meet with you at your convenience to draft appropriate language to incorporate your responsibility to contribute funds or in-lieu construction in the Development Agreements now in process.


