BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$29,000 (\$15,000 from the Sewer Revenue Fund No. 41506 and \$14,000 from FSDRIP Fund No. 79360), is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.


