

RESOLUTION NUMBER R- 265867

ADOPTED ON JUN 02 1986

WHEREAS, on December 1, 1984, the City leased a portion of Lot 17 at Montgomery Field Airport to EXECUTIVE AIR SERVICE, INC. for a three-year term for the purpose of operating an air charter and air ambulance service; and

WHEREAS, EXECUTIVE AIR SERVICE, INC., has requested a 25-year extension of said lease; and


WHEREAS, the City Manager has recommended that proposals to lease Lot 17 on a long term basis be solicited; and

WHEREAS, after considering the matter at its meeting of April 23, 1986, the Public Facilities and Recreation Committee referred the matter to full Council for review without recommendation; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized and directed to negotiate a proposed twenty-five (25) year lease for Lot 17, MONTGOMERY FIELD AIRPORT with EXECUTIVE AIR SERVICE, INC. and to bring the lease back to the City Council for final approval.
