RESOLUTION NUMBER R- 265872  
ADOPTED ON JUN 02 1986

WHEREAS, Section 8330 et seq. of the California Streets and Highways Code provides a procedure for the summary vacation of streets by City Council resolution where the street and alley to be vacated for five consecutive years have been impassable for vehicular travel and no public money was expended for maintenance on the street and alley during such period; and

WHEREAS, the abutting property owners have requested the vacation of the southerly portion of "G" Street west of 27th Street and adjacent to Lots 1 and 42-45, Block 38 of Parrish Loomis Subdivision Map 288 and the north-south alley adjacent to Lots 1-5 and 42, Block 38 of Parrish Loomis Subdivision Map 288; and

WHEREAS, the portion of street to be vacated is not needed for present or prospective public street purposes; and

WHEREAS, those properties adjoining the street to be vacated will continue to have access; and

WHEREAS, the public will benefit from the vacation through improved utilization of land; and

WHEREAS, the vacation is not inconsistent with the General Plan or an approved Community Plan; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

: :

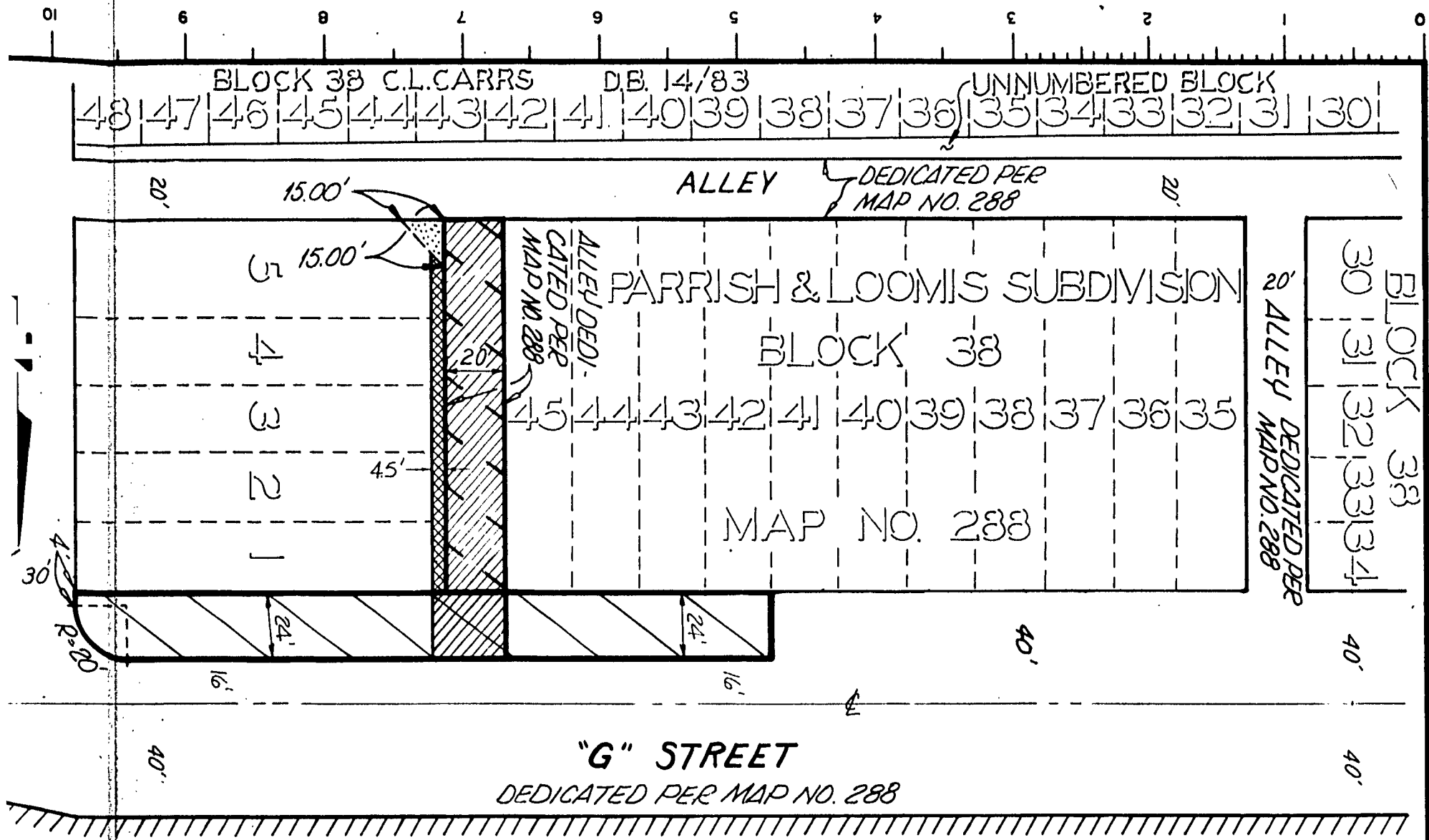
1. That the southerly portion of "G" Street west of 27th Street and the north-south alley adjacent to Lots 1-5 and 42, Block 38 of Parrish Loomis Subdivision Map 288, as more particularly shown on Drawing No. 16604-B on file in the office of the City Clerk as Document No. RR-265872-1, which is by this reference incorporated herein and made a part hereof, be and the same is hereby ordered vacated.

2. That the City Clerk shall then cause a certified copy of this resolution with drawing, attested by him under seal, to be recorded in the office of the County Recorder.
