RESOLUTION NUMBER R- 265880

ADOPTED ON JUN 2 1986

WHEREAS, Section 8330 et seq. of the California Streets and Highways Code provides a procedure for the summary vacation of streets and public service easements by City Council resolution where a street has been superseded by relocation; and

WHEREAS, the vacation of a portion of Black Mountain Road has been initiated by the submission of a tentative map; and

WHEREAS, the vacation of Black Mountain Road east and west of Hartford Avenue and in conjunction with North City West Neighborhood 7 Unit 13 (T.M. 86-0127) is required to facilitate development; and

WHEREAS, those properties adjoining the street to be vacated will continue to have access; and

WHEREAS, the public will benefit from the vacation through improved utilization of land; and

WHEREAS, the vacation is not inconsistent with the General Plan or an approved Community Plan; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That Black Mountain Road east and west of Hartford Avenue and in conjunction with North City West Neighborhood 7 Unit 13 (T.M. 86-0127), as more particularly shown on Exhibit "A," on file in the office of the City Clerk as Document No.


RR- 265880-1, which is by this reference incorporated herein

and made a part hereof, be and the same is hereby ordered vacated.

2. That the resolution shall not become effective unless and until the first final subdivision map for North City West Neighborhood 7 (T.M. 86-0127) has been approved by Council action. In the event that a final subdivision map for North City West Neighborhood 7 is not approved by three years after adoption of this resolution, then this resolution shall become void and be of no further force or effect.

3. That the City Engineer shall advise the City Clerk of the approval of the aforementioned subdivision map, and that the City Clerk shall cause a certified copy of this resolution, with drawing, attested by him under seal, to be recorded in the office of the County Recorder.

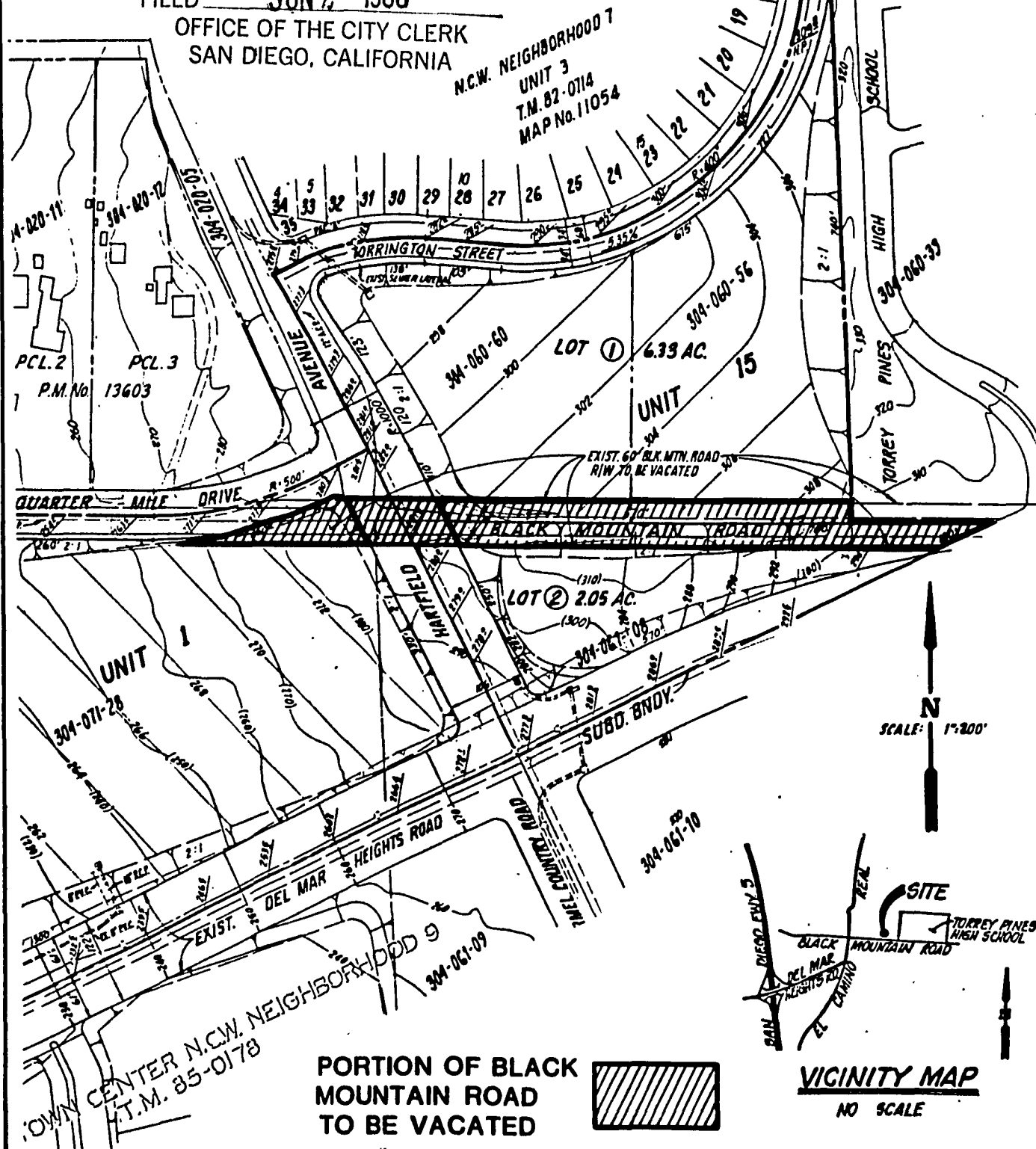
