WHEREAS, the City and County of San Diego are currently in the process of exploring alternative trash-to-energy systems; and

WHEREAS, it has been brought to the attention of City Councilmember Gloria McColl, who is an alternate to the SANDER Citizens Advisory Commission, that there is a unique trash-to-product plant operating in Geneva, Switzerland; and

WHEREAS, it would be beneficial to the City Council and the SANDER Citizens Advisory Commission to have first-hand information about this new process which converts household trash to a multi-use construction material through a noncombustion process; and

WHEREAS, the local office of Catrel, S.A., California Catrel, S.A. has invited Councilmember McColl to visit its plant at her own expense, as a representative of The City of San Diego in order to study this one-of-a-kind process; and

WHEREAS, such visit will provide valuable information for the Council and at no cost to the City; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that Councilmember Gloria McColl be and she is hereby authorized to visit and tour the Catrel, S.A. plant in Geneva, Switzerland on behalf of and at no cost to The City of San Diego, for the purpose of gathering information for the City Council about the process which converts household trash to multi-use construction material through a noncombustion process.
