



WALLACE; OSCAR BARRIOS and MARIA G. BARRIOS; CARLTON C. LEONARD and HAZEL M. LEONARD; all executed in favor of The City of San Diego, copies of which deeds are on file in the Office of the City Clerk as Document Nos. RR-265899-1, RR-265899-2, RR-265899-3, RR-265899-4 and RR-265899-5, granting to said City easements for public street purposes in portions of the Southeast Quarter of Section 27, T18S, R2W, SBM, and the Southwest Quarter of the Northeast Quarter of Section 28, T18S, R2W, SBM, as more particularly described in said deeds, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for public streets, and the portion of Section 27 is hereby named IRIS AVENUE, and the portion of Section 28 is hereby named 19TH STREET.
