

Nachant, said contract having been filed in the office of the City Clerk as Document No. RR-262762, be and the same is hereby approved; and the changes therein set forth, amounting to a net increase in the contract price of \$63,641.30.

BE IT FURTHER RESOLVED, that the City Auditor is hereby authorized to transfer \$73,600 from Fund No. 39094, Mid City Park Development to CIP No. 29-441.0, Colina Del Sol Community Park Improvements, solely and exclusively for the purpose of funding this change order.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$73,600 from CIP NO. 29-441.0, Colina Del Sol Community Park Improvements, is hereby authorized, solely and exclusively



for the purpose of supplementing expenditures previously authorized by Resolution No. R-262762, adopted March 25, 1985.
