She suggested providing laminated reference cards containing emergency phone numbers for field employees. Although savings are difficult to identify, this is considered to be a significant operational improvement.
Ernest DeLeon	Utilities	\$90.00	Mr. DeLeon is a Water Plant Operator in the Water Quality Division. He suggested installing telephone answering machines at the three filtration plants. Although savings are difficult to identify, this is considered to be a significant operational improvement.
