Pedro Moreno	Clerks	\$45.00	Mr. Moreno is a Stock Clerk in the Records Division. He suggested temporarily storing record boxes on pallets to avoid water damage. Although savings are difficult to identify, this is considered to be a significant operational improvement.
Tony Padilla	Utilities	\$45.00	Mr. Padilla is an Equipment Technician with the Metro Division. He suggested the installation of an explosion proof, permanent light in the influent area at Metro #1. Although savings are difficult to identify, this is considered to be a significant safety improvement. This is a partial award pending a 12-month review.
Pedro Moreno	Clerks	\$31.20	Mr. Moreno is a Stock Clerk in the Records Division. He suggested destroying daily log forms from 1971-1974, to save file space. This is based on a cost of \$104 per cubic foot. This is a full award.
