

RESOLUTION NUMBER R- 265932

ADOPTED ON JUN 10 1986

WHEREAS, the Planning Commission of The City of San Diego held concurrent public hearings on April 24, 1986, to consider the proposed amendment of the SERRA MESA COMMUNITY PLAN and amendment of the General Plan Map in order to retain consistency between said plans; and

WHEREAS, the Council of The City of San Diego having considered all maps, exhibits, written documents and materials in this matter, having heard all oral presentations given, and being fully advised concerning the same; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That this Council hereby approves the amendment of that plan entitled SERRA MESA COMMUNITY PLAN, a copy of which is on file in the office of the City Clerk as Document No.

**RR-265932**, for the purpose of redesignating a 2.5-acre site located in the Murphy Canyon Gateway from light industrial to visitor-serving commercial. This action is in conjunction with a rezone from the M-1A to CA Zone.

2. That the amendment of the SERRA MESA COMMUNITY PLAN shall become effective upon adoption of an appropriate amendment of the PROGRESS GUIDE AND GENERAL PLAN FOR THE CITY OF SAN DIEGO incorporating said plans at the next scheduled omnibus hearing.
