APPROVING MAP OF CARMEL VALLEY - UNIT NO. 6.

BE IT RESOLVED, by the Council of The City of San Diego that said Council hereby finds that certain map surveyed by Reginald D. Harvey, Jr., Licensed Land Surveyor, entitled "CARMEL VALLEY - UNIT NO. 6 being a subdivision of those portions of Parcel 2 and 3 of Parcel Map No. 11102, in the City of San Diego, County of San Diego, State of California, filed in the office of the County Recorder of San Diego County, March 13, 1981 as File No.

81-077513 of official records, is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: Ocean Valley Lane, Foxhollow Court, Carmel Center Road, Pine Meadow Court and Sunset Bluff, and said streets are hereby declared to be public streets and dedicated to the public use, as dedicated and shown on said map and subject to the conditions set forth thereon.


BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the construction and maintenance of general utility facilities, as granted and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easement for open space over Parcels "A," "B," "C," "D" and "E," as granted and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public streets are accepted on behalf of the public as heretofore stated, together with the easements with the right of ingress and egress for the construction and maintenance of general utilities, as well as the open space easement, all as granted and shown on this map within this subdivision, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
