

RESOLUTION NUMBER R- 265960

ADOPTED ON JUN 16 1986

APPROVING MAP OF HORTON CANYON.

BE IT RESOLVED, by the Council of The City of San Diego that said Council hereby finds that certain map surveyed by James L. Meyer, Licensed Land Surveyor, entitled "HORTON CANYON being a subdivision of Lot A, Lot B and the north half of Lot C, in Block 402, Block 403 and a portion of Block 404 of Horton's Addition, in the City of San Diego, County of San Diego, State of California, according to map thereof made by L. L. Lockling on file in the office of the County Recorder of San Diego County, together with Jackdaw Street, Upas Street and a portion of Horton Avenue all as closed and vacated to public use," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: pedestrian and non-motor vehicular easement and said pedestrian and non-motor vehicular easement are hereby declared to be a public pedestrian and non-motor vehicular easement and dedicated to the public use, as dedicated and shown on said map and subject to the conditions as set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the construction and maintenance of water, sewer and drainage facilities, as granted and shown on said map and subject to the conditions set forth thereon.


BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said pedestrian and non-motor vehicular easement is accepted on behalf of the public as heretofore stated, together with the easements with the right of ingress and egress for the construction and maintenance of water, sewer and drainage facilities, all as granted and shown on this map within this subdivision, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.

BE IT FURTHER RESOLVED, that the City Clerk is hereby directed to record the street vacation of Jackdaw Street, Upas Street and a portion of Horton Avenue, approved by Council Resolution Nos. R-260423 and R-265243 on April 9, 1984 and March 17, 1986, concurrently with the filing of the map.
