

RESOLUTION NUMBER R- 265976 ADOPTED ON JUN 1 6 1986

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- That the City Auditor and Comptroller is hereby authorized to open Fund No. 78010 for the purpose of depositing Public Utilities Commission Case 8209 Utility Undergrounding Allocation Funds for the 47th Street (Imperial Avenue to Highway 94) Underground Utility District.
- That the City Treasurer is hereby authorized to receive these funds from the San Diego Gas & Electric Company.
- That pursuant to Council Policy No. 800-2, payments to all qualified property owners in the 47th Street (Imperial Avenue to Highway 94) Underground Utility District as reimbursement for electrical service underground conversion work done on private property from Case 8209 funds deposited by San Diego Gas & Electric Company with the City Treasurer for this purpose.
- 4. That the City Auditor and Comptroller is hereby authorized to return to San Diego Gas & Electric Company any



undisbursed funds upon written notice from San Diego Gas & Electric Company to the City that all electric service conversions within a particular district have been completed.
