BE IT RESOLVED, by the Council of The City of San Diego, that the acceptance by the City Manager of a street easement deed of THRIFTY OIL, a California corporation, executed in favor of The City of San Diego, bearing date of March 27, 1986, a copy of which deed is on file in the Office of the City Clerk as Document No. RR- 265977, granting to said City an easement for public street purposes in a portion of Lots 35 through 40 and a portion of Lots 11 and 12, all in Block 50 of Park Villas, Map 438, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for public streets, and the same are hereby named BOUNDARY STREET and BANCROFT STREET.

BE IT FURTHER RESOLVED, that the City Clerk shall cause the deed and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
