WHEREAS, the vacation of the City's interest in an unneeded sewer easement affecting Lot 1, Block 178 and Lot 11, Block 179, Middletown, as more particularly shown on Drawing No. 16671-B attached hereto as Exhibit "A", has been requested by the affected property owner; and

WHEREAS, the owner wishes to clear title to his land of all unnecessary easements in order to permit better utilization of the property; and

WHEREAS, the herein-described easement has not been used for five years, and is surplus to City needs; and



BE IT RESOLVED, by the Council of The City of San Diego, as follows:

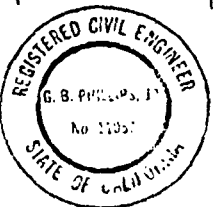
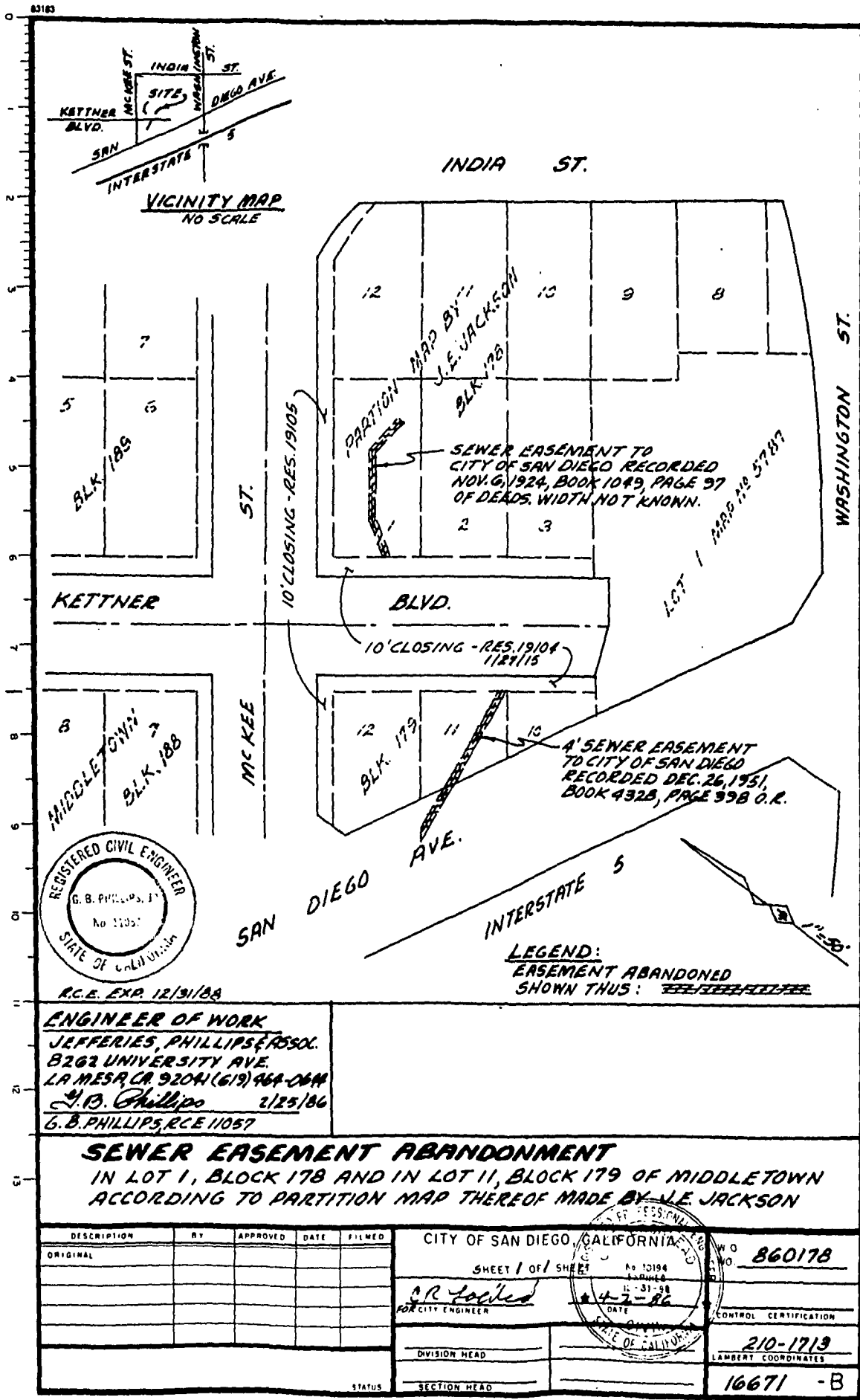

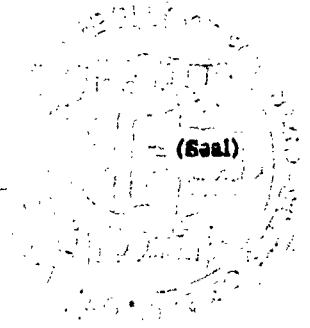
