RESOLUTION NUMBER R- 265998

WHEREAS, in 1985, the City Manager applied for and received a \$50,000 grant from the Federal Department of Commerce, Minority Business Development Agency for funding of a Minority Business Assistance Project; and

WHEREAS, the grant award covered the period of July 1, 1985 to June 30, 1986, and funds were designated to augment the City's Minority-Women Business Enterprise Program; and

WHEREAS, the Department of Commerce has requested the City Manager to submit a revised proposal and budget for continued funding beginning July 1, 1986 and ending June 30, 1987; and

WHEREAS, continued funding at a level of \$50,000 will provide resources essential to the implementation of the City's Minority and Business Enterprise Program; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized to submit a grant application to the Minority Business Development Agency of the United States Department of Commerce, for the sum of \$50,000 to be used solely and exclusively for funding a Minority Business Assistance Project.

BE IT FURTHER RESOLVED, that the City Manager is hereby fully authorized to accept the grant and execute a grant agreement pursuant to the terms and conditions of the grant application,
