APPROVING MAP OF REVERSIONARY MAP OF DEL CERRO MESA.

BE IT RESOLVED, by the Council of The City of San Diego as follows:

Said Council hereby finds that certain map surveyed by James L. Meyer, Licensed Land Surveyor, entitled "REVERSIONARY MAP OF DEL CERRO MESA being a reversion to acreage of Lots 1 to 21 inclusive of Del Cerro Mesa, in the City of San Diego, County of San Diego, State of California, according to map thereof No. 10736, filed in the office of the County Recorder of San Diego County, October 12, 1983, together with Camino Largo, as closed and vacated to public use by filing of the Reversionary Map as provided in Section 66499.18 of the Subdivision Map Act, including a portion of Navajo Road which remains dedicated to public use," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the reversion to acreage of land shown thereon is hereby approved and accepted.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said reversionary map.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
