APPROVING MAP OF SOLEDAD CREST P.R.D.

BE IT RESOLVED, by the Council of The City of San Diego as follows:

Said Council hereby finds that certain map surveyed by Andrew E. Lambert, Licensed Land Surveyor, entitled "SOLEDAD CREST P.R.D. being a subdivision of Lot 26 of La Jolla Harbour Heights in the City of San Diego, County of San Diego, State of California, according to map thereof No. 6603, filed in the office of the County Recorder of San Diego County, March 23, 1970," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the building restricted easement over, upon or across a portion of Lot 5, as granted and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
