BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That this Council hereby waives the provision of Council Policy No. 100-3 regarding the funding of religious organizations.

2. That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with Triple Crown Youth Coalition, Inc., to provide supervision of a brush removal project on public property from June 2, 1986 to September 30, 1986, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 266015.

3. That the City Manager be and he is hereby directed to review individual areas proposed for brush removal for any potential environmental impacts prior to actual work on the site.

4. That the expenditure of an amount not to exceed \$34,144 from the General Fund, Unallocated Reserve, is hereby authorized, solely and exclusively for the purpose of providing funds for the above program.



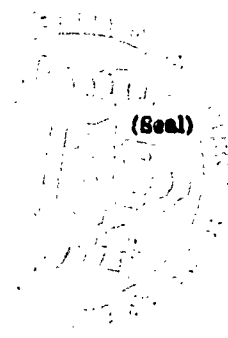
