RESOLUTION NUMBER R-266016

ADOPTED ON JUNE 16, 1986

WHEREAS, present law facilitates the voluntary transfer of water and water rights, and directs the Department of Water Resources, State Water Resources Control Board, and other State agencies to encourage such transfer; and

WHEREAS, AB 2746 (Katz) would prohibit the State and any regional or local public agency from withholding use of its water conveyance facilities from others provided that the facility has unused capacity and the parties desiring to use the facility pay fair market value for the use; and


WHEREAS, in its Report No. 86-33, dated June 11, 1986, the Intergovernmental Relations Department recommended that the City support AB 2746; and

WHEREAS, the matter was approved unanimously by the Rules Committee on June 16, 1986 and forwarded to the full Council for appropriate action; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Council, for and on behalf of said City, hereby expresses support for AB 2746 (Katz) as recommended by the Intergovernmental Relations Department in its Report No. 86-33, dated June 11, 1986.
